Meeting of the National Council for Civil Society

Tirana, February 12, 2024

The Civil Society Support Agency, acting as the Technical Secretariat of the National Civil Society Council, held the next meeting of the National Civil Society Council on February 12, 2024 at 2:00 PM at the Center for Openness and Dialogue at the Prime Minister's Office.





This was the first meeting of the National Council for Civil Society for 2024. Participants were the permanent members of the Council, and representatives from the High Judicial Council, SASPAC, the General Directorate of Taxes, etc. The topics discussed at the meeting were: a) Issues regarding the electronic registry of NGOs and the connection with the new system being prepared by the Tax Directorate;

b) The applicability of the Law that exempts CSOs from VAT liability;

c) Update on the process of drafting the New Civil Society Roadmap,

d) Proposals for the calendar of activities of the NCSC for 2024;

e) Discussions on amendments to Law No. 81/2017 "On Protected Areas";





Announcement of Call No. 17 at the Civil Society Support Agency

Tirana, February 23, 2024

The Civil Society Support Agency (CSSA), within the framework of open and transparent competition according to the criteria set out in Law No. 10 093, dated 09.03.2009 "On the organization and functioning of the Civil Society Support Agency", in accordance with its statute and mission: Financial assistance for a sustainable development of civil society, and the creation of favorable conditions for civic initiatives in the public interest and in the



framework of Law No. 146/2014 "On Public Notice and Consultation"; Announces the opening of the 17th call.

During the meetings held by representatives of the AMSCS and various NGOs or local governments, our institution presented the goals of the meetings and listened to their proposals for priorities according to the field of activity, and in the end, by consulting as a whole, the proposals for priorities were grouped.

From the numerous discussions held by the

participants in the meetings, representatives of NGOs and other interest groups, as well as from the review of all the material received electronically and in written form (hard copy), where the participants listed all their suggestions, it was concluded that Civil Society faces numerous problems and challenges, which require solutions. Taking into account the role of the AMSCS in accordance with the law in force after the meetings scheduled within the framework of the public consultation were finalized.



The suggestions/proposals for priorities are as follows:

- ✤ Corruption and the fight against it
- ✤ Local good governance.
- Monitoring the Justice Reform and the vetting process.
- Protection of children's rights.
- Youth engagement in awareness campaigns to promote young talents in art, culture and sculpture.
- Support and accessibility for people with disabilities, social inclusion of people with intellectual disabilities.
- Sensitization, mobilization and activation of young people in integration processes, volunteerism and philanthropy.
- Sensitizing young people to the use of protective measures against sexually transmitted diseases.
- Information and awareness-raising on the rights of young people, mainly in rural areas.
- Support for vocational education, empowerment and employment of women and youth.
- Identification, addressing and development of regional natural areas with tourism potential at risk from uncontrolled economic developments.
- Promoting religious harmony and coexistence.
- ✤ Improving social services.
- Support for the elderly, provision of social services in the home, etc.
- ♦ Increasing the capacities of NGOs to design concrete projects, especially local ones.
- Supporting environmental protection projects with a focus on forests and thermal springs; Focusing on and addressing the damage caused during the transition and in the future in Albanian marine and coastal areas.
- Development of family tourism taking into account the traditional products of the area; alternative tourism/adventure tourism.

This evaluation report will also serve as a starting point for the drafting of the next strategic document for civil society.

The meeting was attended by members of the National Civil Society Council, representatives from the European Delegation office in Albania, national and international experts from civil society, as well as representatives of the Technical Assistance for Civil Society Organizations in the Western Balkans and Turkey.



NGO Exchange Program

Tirana, June 7, 2024



On June 7, 2024, Partners Albania organized the third edition of the "NGO Exchange Program" at the premises of the Civil Society Support Agency.

The program aims to contribute to strengthening the capacities of the sector, increasing access



and cooperation between NGOs and public and private institutions in the process of designing and implementing advocacy initiatives in the country with the aim of addressing the needs of the interest groups they serve.

The program is a combination of lectures, discussions,

with experts and institutional representatives, and visits to public and private institutions and partner NGOs. Representatives of the NGOs selected in the program are also expected to apply the knowledge gained in their local initiatives.

Society Forum in Belgrade

Belgrade, June 12, 2024

Representatives from the Agency to Support the civile Society, ASCS, are participating in the EU Civil Society Forum 2024 for the Western Balkans and Turkey. The program was organized in six panels and designed The agenda includes the following sessions:

- The EU and civil society in the Western Balkans – The Growth Plan and the new momentum for EU enlargement.
- Launch of the second Evaluation within the framework of DG NEAR guidelines for EU Support to Civil Society in the Balkan region, for 2023.
- A World Café session on topics proposed by conference delegates.



The project is funded by the EU Technical Assistance to Civil Society Organizations (EU TACSO 3) in the Western Balkans and Turkey, and is organized in Belgrade, Serbia on 11, 12 and 13 June 2024.

This report presents the second evaluation for the period 2021-2027 under the revised DG NEAR Guidelines for EU Support to Civil Society in the Enlargement Region. The Guidelines outline the path through which the EU aspires to support civil society in the enlargement region over this seven-year period. This evaluation report provides evidence on the situation against the indicators of the Guidelines for 2023, presenting the situation in the region, namely in Albania, Bosnia and Herzegovina, Kosovo, Montenegro, North Macedonia, Serbia and Turkey.

The analysis presented in this report is based on data collected from primary and secondary sources by the EU TACSO 3 team. Primary research included surveys of CSOs and public officials, focus group discussions and interviews with CSO representatives, interviews with relevant public officials, as well as a legal analysis of relevant laws conducted by external legal experts. In addition, secondary sources

such as reports produced by CSOs, national human rights institutions, governments and others. The CSO survey was widely distributed and yielded 908 valid responses from across the region.



Cooperation between authorities and civil society continued to require significant improvement. Similarly, the capacity and sustainability of CSOs continued to require strengthening in the areas of accountability, transparency and organizational policy, while they were again positively assessed in the areas of organizational learning, stakeholder consultation and financial diversification.

VI National Conference "The Right to Information – Building Trust, Promoting Transparency, Accountability and Integrity in Anti-Corruption Policies"

Tirana, June 26, 2024

On 26.06.2024, the VI Edition of the National Conference was held on the topic "Right to Information - Building Trust - Promoting Transparency, Accountability and Integrity in Anti-Corruption Policies". Transparency, accountability and access to information are key to building sustainable and democratic institutions. The right to access information is essential in creating accountable and integrity-based institutions. If citizens are uninformed, they cannot hold their government accountable for corruption

in the public sector. Access to quality information serves as a catalyst for an open and democratic society and for guaranteeing citizens' rights.

This conference brought together, in the form of a roundtable discussion, public authorities represented by the heads and coordinators for the right to information, the anti-corruption coordinator, as well as the coordinator for public notification and consultation, of central, local, independent institutions and the judiciary, together with experts and representatives of civil society. Its role is to serve to explore the critical role of access to information according to the principles of transparency, inclusiveness and accountability, as well as to discuss the state of transparency of Albanian public authorities, existing problems, as well as proposals for its increase to the required levels.

The focus of the Conference was the indispensable role of civil society and the media in promoting access to information and transparency and in forming responsible and integrity-based institutions, as well as sharing best practices in strengthening transparency and accountability, as pillars of the preventive approach to anti-corruption. For this reason, representatives from the Civil Society Support Agency (CSSA) were an important part of the meeting.

Draft Intersectoral Justice Strategy 2024-2030 announced for consultation

Tirana, September 12, 2024



Justice reform is one of the key and important priorities of the Albanian Government, which aims to strengthen the rule of law, advance with the reforms initiated in the justice system and respect fundamental human rights and freedoms. In this context, justice reform is based on an independent, accountable, transparent justice system, with high professional integrity, efficient, which enables the

increase of public trust in the judicial system and in that of the prosecution and aims to increase the quality of justice services by providing quality justice at the level and in accordance with EU standards.

On 12.09.2024, the Minister of Justice proposed the Draft Act for the approval of the Intersectoral Justice Strategy, Action Plan 2024–2030 and Indicator Passport (SND III hereinafter), as a political document of the Albanian Government with the major objective: "Consolidation of the achievements of justice reform in accordance with the best European standards". The Ministry of Justice, within the framework of the consultation process, welcomes suggestions from citizens, experts in the field, from all interested institutions, non-profit organizations and civil society that provide contributions in the field of justice.

Meeting of the National Council for Civil Society (NCCS)

Tirana, October 16, 2024

The next meeting of the National Council for Civil Society (NCCS) is being held, which was organized by The Agency for Civil Society Support (AMSHC), located within the premises of the Ministry of Health and Social Protection, where had to invited members from the organization of society civil society and representative members of Albanian public institutions.



Under the leadership of Ms. Albana Koçiu, Chair of the Council, and in the presence of members of the government, civil society, and the Agency for the support the Civil Society, the second national meeting of the NSCS for 2024 was held. Also present at this meeting was the Executive Director of the State Agency for Strategic Programming and Aid Coordination, Ms. Eridana Çano.

During the discussions, proposals and opinions were exchanged regarding issues related to the proper functioning of the Council and the civil society sector.



Concrete proposals were given by civil society representatives regarding:

(i) The establishment of the public health professional order;

(ii) Public consultations on the inclusion of civil society in the draft medium-term budget, as well as on the implementation of the instruction of the Ministry of Infrastructure and Energy for the reimbursement of a certain amount of m3 of water for families in need.



NGO Exchange Program

Tirana, October 23 , 2024

On October 23, 2024, Partners Albania organized the fourth edition of the "NGO Exchange Program" at the premises of the Civil Society Support Agency.



The program aims to contribute to strengthening the capacities of the sector, increasing access and cooperation between NGOs and public and private institutions in the process of designing and implementing advocacy initiatives in the country with the aim of addressing the needs of the interest groups they serve.



The program is a combination of lectures, discussions, with experts and representatives of institutions, and visits to public, private institutions and partner NGOs. Also, representatives of the NGOs selected in the program are expected to apply the knowledge gained in their local initiatives. The Academy is a 9-month program dedicated to Leaders and Senior Managers of civil society organizations, which aims to increase their capacity in organizational management and sustainable development of the organization.

Maximum amount of grant funding for Call for Proposals 17 was determined Supervisory Board until IN <u>2 (two) million) lek</u> with one duration 6-12 months ;

meanwhile that maximum amount financed by grant For Draft Proposal About this There was a call. *1.8 million ALL*

<u>150 NGO applicants</u> have applied ; with a total amount requested by the ASCS for the total number of projects of: <u>267,799,959 lek.</u>

The Supervisory Board has announced <u>73 Project Proposals as winners</u> with a total funded amount of <u>96,500,000 lek.</u>

Statistics regarding the distribution of projects by Priority Areas show us that the most important item is that of Priority 2 (two):


